The total transaction value is 154 million euros which encompasses both companies and related receivables. The completion of the transaction is conditional upon obtaining the mandatory regulatory approvals and other transfer conditions.**

and Smartwings management: together, we aim to spread our wings across Europe with two distinctive brands, Smartwings and Pegasus Airlines. This integration is not just about growth, but about creating resilient, technology-driven companies that put safety at the heart of operations and are prepared to meet the future to deliver easy, personalised and efficient travel experiences.
