IS-BAH follows the structure of the International Standard for Business Aircraft Operations (IS-BAO) Program and incorporates the NATA Safety 1st Ground Audit Program. IS-BAH is the global industry standard for handlers and operators around the world to meet the coming SMS requirements from the International Civil Aviation Organization (ICAO).**

IS-BAH offers Fixed Based Operators (FBO) and Business Aircraft Handling Agents (BAHA) a scalable, industry-developed code of best practice centered around Safety Management System (SMS) principles adopted by ICAO and other operations-critical industries. Conforming to these standards and recommended practices is voluntary.
