Avia Traffic aircraft was subjected to the full maintenance workscope including C2+C1, AD/SB + A1 + A2 + A3 + A4 checks and CPCP program. This base maintenance was performed under a certificate issued by Kyrgyzstan aviation authority authorizing VD Gulf to accomplish all types of line and base maintenance services for 737-300/400/500.
